1. INTRODUCTION

Public company Motorways of Federation of Bosnia and Herzegovina ltd. Mostar (hereinafter: JP Autoceste FBiH) was established by the Law on Roads of the Federation of Bosnia and Herzegovina on 1st January 2011. The activity of JP Autoceste FBiH is defined by the Law on roads of the Federation of BH and on the basis on this Law JP Autoceste FBiH has become the holder and the implementer of a very complex and important project regarding the construction of the motorway on Corridor Vc which connects Eastern and Central Europe with the Mediterranean coast. The legal framework for the company in addition to the Law on roads is also defined by Law on the motorways on Corridor Vc, the Company law and the Law on public companies in the Federation and other regulations in Bosnia and Herzegovina.

At the second Pan - European conference on transport held in Crete in year 1994, the European Union defined the Union's priorities in the domain of infrastructure and transport corridors to the east until year 2015.

At the third Pan - European conference held in Helsinki in 1997, the number of corridors has been increased to ten and changes have been made. One of these changes was the introduction of Corridor Vc (Budapest - Osijek - Sarajevo - Ploče) in the basic European transport network.

Corridor Vc is a multimodal motorway corridor connecting Hungary (Budapest) and Croatia (Luka Ploče) via Osijek (Croatia) and Sarajevo (Bosnia and Herzegovina) and is also the largest transport infrastructure project in Bosnia and Herzegovina with a total length of about 320 km. The construction of Corridor Vc motorway improves BH's connection with neighbouring countries and improves the potential for economic development. The project is strongly supported by the Government of Federation of BH and is expected to enable Bosnia and Herzegovina better integration with European economic and social structures in Europe.

Corridor Vc in BH includes four main sections (stated in Government documents as Lots) as follows:

- Lot 1: Svilaj on the Sava river (connection to Corridor X) Doboj South;
- Lot 2: Doboj South Sarajevo South (Tarčin);
- Lot 3: Sarajevo South (Tarčin) Mostar North;
- Lot 4: Mostar North Bijača on the southern border with Croatia.

A total of 92 km of motorway on Corridor Vc has been constructed, put into operation and it refers to the following sections:

- Zenica South Sarajevo North;
- Sarajevo North Sarajevo West;
- Sarajevo West Tarčin;
- Zvirovići Bijača

The sections, on which the construction works have been completed and which will be put into operation after the conditions have been acquired, are as follows:

- Svilaj Odžak
- Drivuša Klopče
- Klopče Donja Gračanica
- Part of the subsection Donja Gračanica Zenica Tunnel

This is a Progress report on project implementation within the competence of JP Autoceste FBiH as of December 31th, 2020.

2. LOAN AGREEMENTS

In accordance with the Law on roads of FBiH, financial resources for maintenance, protection, reconstruction, reconstruction and construction are provided from:

- Public revenues (revenues from excise duties, tolls, revenues from the use of road land);
- Loans and
- Donation (grants).

For the construction of motorway sections on Corridor Vc in the Federation of BiH, Bosnia and Herzegovina is signing loan agreements or finance contracts with international financial institutions. In the period from 2008 to 2019, agreements have been concluded with the European Investment Bank, the European Bank for Reconstruction and Development, the OPEC Fund and the Kuwait Fund for Arab Economic Development. Basic information on all concluded loan agreements for the construction of the motorway on Corridor Vc is given in the three tables below.

3. EU GRANTS

Given the fact that the construction of Corridor Vc is financed from funds by international financial institutions that contribute to the WBIF (EIB or EBRD), JP Autoceste is able to apply for grants from the European Union. So far, more than EUR 165 million have been approved for the construction of Corridor Vc in the Federation through 10 grant applications. One of the grants has been implemented for its most part, while the other grants are at various stages of administrative procedure which precedes the effectivness of the grant funds.

At the end of October 2020 JP Autoceste submitted drafts of grant applications to the Sixth WBIF Call for the investment grants for projects on Corridor Vc, as follows:

- Poprikuše Medakovo in the amount of: 76.122.367 EUR
- Ovčari entrance to the Tunnel Prenj in the amount of: 39.740.000 EUR
- Tunnel Prenj in the amount of: 52.588.000 EUR
- Salakovac Mostar North in the amount of: 35.340.000 EUR

In December 2020, JP Autoceste was informed (by a Letter of the Directorate for European Integration) that after the adoption of the Economic and Investment Plan for the Western Balkans, the European Commission harmonized WBIF application criteria with the mentioned Plan and prolonged the deadline for the Sixth WBIF Call for Investment grants until February 26th 2021. It is important to point out that the allowed percentage of co-financing for road infrastructure has been increased and now amounts to 40% (instead of the previous 20%).

It was accented that in the Sixth WBIF Call it is necessary to re-propose the application Mostar South - Kvanj Tunnel, which was positively screened in the Fifth Call, but was not adopted by the WBIF Board of Directors. Within the set deadline JP Autoceste will update the already submitted applications and harmonize them with the new WBIF rules.

In addition to investment grants, WBIF has approved technical assistance grants for certain projects on Corridor Vc to be implemented through the IPF (Infrastructure Project Facility). As a result of these grants, JP Autoceste will receive studies and project documentation. Details on technical assistance grants are given in the table below.



PROJECT DOCUMENTATION	By the end of September 2020, the innovated Detailed design for the sections Putnikovo brdo - Karuše and Karuše - Medakovo has been completed. The revision of documentation is in progress.					
CONSENTS AND PERMITS	In June 2016, the Federal Ministry of Environment and Tourism has issued a Decision on the renewed environmental permit for the complete LOT 1 Svilaj - Doboj South (Karuše), while in September 2019 it has issued an environmental permit for the complete LOT 2 Doboj South (Karuše) - Sarajevo North. For the subsection Karuše - Medakovo an urban permit has been obtained in 2015. For the subsection Putnikovo brdo - Karuše, all necessary prior consents have been obtained. The request for the issuance of the urban permit will be submitted after the update of the existing documentation and the submitted Preliminary design. The construction permit will be obtained after fulfilling the legal conditions which includes the revised Detailed design and the completion of the expropriation procedure.					
LAND AQUISITION	The alignment passes through the municipalities of Tešanj, Doboj South and Usora. The expropriation procedure was initiated in all the municipalities. In the Municipality of Tešanj for c.m. Kraševo, 56 agreements on compensation for expropriated land plots have already been concluded. In the Municipality of Usora for c.m. Tešanjka, 2 agreements on compensation for expropriated land plots have been concluded. In the Municipality of Doboj Jug on-site investigations are ongoing, after which the municipality will start drafting decisions on expropriation.					
PROCURMENT – CONTRACTOR FOR WORKS	Public procurement is conducted in accordance with international procedures through the Open procedure with prequalification. The procedure of prequalification has been published in September 2020. The deadline for submission of bids was extended to November 3 rd 2020. The evaluation of bids is in progress.

Urban consent has been obtained. The construction permit will be obtained after fulfilling the legal conditions, which includes the revised Detailed design and the completion of the expropriation procedure.
LAND AQUISITION	The alignment passes through the municipalities of Tešanj. The expropriation procedure is ongoing. The characteristic of this section is the large number of residential buildings that have to be expropriated. In the reporting period, onsites inspections have been completed for land plots in c.o. Medakovo and 20 cases have been completed (out of approx. 400 cases).
PROCUREMENT	The procurement process will be initiated in line with the Lead IFI's rules once the conditions for initiating the procedure have been met.

CONSENTS AND PERMITS	In September 2019, the Federal Ministry of Environment and Tourism issued an environmental permit for the complete LOT 2 Doboj South (Karuše) - Sarajevo North. The request for the issuance of the urban permit will be submitted after the selected Consultant in charge of preparing the Detailed design consolidates and completes the previously prepared project documentation along with the new one in order to obtain all approvals without obstacles. The construction permit will be obtained after fulfilling the legal conditions which includes the revised Detailed design and the completion of the expropriation procedure.
LAND AQUISITION	The expropriation procedure based on the available expropriation studies for 6.2 km of the route, was initiated in the municipality of Žepče. Out of a total of 279 land plots in 4 cadastral municipalities in Žepče, 182 land plots have been expropriated, which makes up a total of 65.23 %.
PROCUREMENT	The procurement process will be initiated in accordance with the Lead IFI's rules once the conditions for initiating the procedure have been met.

7. ENVIRONMENTAL IMPACT

Law on Environmental Protection (published in the Official Gazette FBiH n. 33/03 and 38/09) defines the conditions and procedures for issuance of Environmental Permit in Federation. Federal Ministry of Environment and Tourism is incharged for issuance of environmental permits for motorway sections on Corridor Vc. Data about all acquired environmental permits for motorway sections under preparation and under construction are contained in chapters 5 and 6 of this Report.

Environmental permit prescribes general and special mitigation measures to avoid negative impacts on the environment during the construction phase and during the exploitation phase. Special mitigation measures are prescribed to avoid negative impacts on: population, microclimate, water, air, soil, flora, fauna, landscape, protected areas, cultural and historical heritage and infrastructure. Special measures are prescribed also for protection from noise and vibrations.

Contractor is incharged for implementation of measures prescribed by environmental permit during the construction phase. Supervision consultant is supervising and following the implementation of prescribed measures.

Implementation of prescribed mesures during the exploitation phase is a task of JP Autoceste. JP Autoceste is outsourcing consultants for specific services as monitoring of drainage system, monitoring of noise level etc.

Also, folloving the Environmental Permit JP Autoceste is preparing annual reports for the Federal ministry of Environment and Tourism about the state of environment.

Besides the comitments defined by federal laws, JP Autoceste (together with contractors and supervision consultants) is obliged to implement and follow the environmental and social standards of european banks which implies: preparation of plans (environmental and social plan, biodiversity management plan, resettlement action plan, stekeholder engagement plan etc.) and reporting on implementation of plans for every section financed by EIB or EBRD.

Also, Annual Environmental and Social Report for all sections on Corridor Vc is being delivered once a year to the EBRD whilist the EIB is being informed semiannually trough specific reports following each finance contract.



Cash Flow Chart 1. Vranduk - Ponirak





Cash Flow Chart 2. Ponirak - Vraca



Cash Flow Chart 3. Donja Gračanica (Zenica Sjever) - Tunnel Zenica







Cash Flow Chart 5.2 Tarčin – Ivan: LOT 2






