The above named client intends to use part of the proceeds of a loan from/grant administered by the European Bank for Reconstruction and Development (the Bank) towards the cost of the above named project.

Additional financing information:

The PC Motorways of the Federation of Bosnia and Herzegovina Ltd has submitted to the Bank their intention to use the proceeds of a loan from the European Bank for Reconstruction and Development (the "Bank") in the amount of EUR 97,2 million and a loan from the European Investment Bank (EIB) in the amount of EUR 97,2 million to finance the construction of priority motorway sections along the international transport Corridor Vc. The remaining funds for the project, which has a total estimated cost of EUR 249,6 million, shall be secured from the expected WBIF grant and Employer's own funds. The total Estimated Project Value includes the estimated cost for implementation of the three envisaged motorway sections as presented below.
