The Services related to temporary supervision and administration of the works contract, quality control, as well as reporting in line with the provisions of the underlying works to be performed under FIDIC 1999 GCC for employer design works. On June 20th 2025, the procuring entity invited a single suitable Consultant to submit technical and financial proposals to provide consulting services for the temporary supervision of works for the construction of motorway Corridor Vc, section Ozimice to Poprikuše. The proposal was required to be within a fixed budget ceiling. The proposal was evaluated as consistent with the requirements set down in the Request for Proposal and the contract was accordingly awarded on July 25th 2025. The proceeds of the Bank's loan are not be used for the purpose of any payment to persons or entities, or for any

import of goods, if such payment or import is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations or under a law of official regulation of the Client's country.

Extreme urgency brought about by events unforeseeable for the buyer

Other justification: Due to unforeseeable events, the procuring entity was unable to conclude successfully the competitive selection of the supervision engineer services for the section Ozimice to Poprikuse (see OJEU 343352 2025, issue 102/2025). However, the procuring entity had already awarded the works contract for which those supervision services were required. In order to avoid delay and incur additional costs whilst a new competitive selection procedure is performed for the supervision services, the procuring entity used a negotiated procedure without prior call for competition to award a contract for temporary engineer services. This temporary engineer services contract has a fixed ceiling and fixed end date. The procuring entity will commence a new competitive selection procedure for the permanent supervision services which will follow on from these temporary engineer services.
