1. INTRODUCTION

The Public Company Motorways of the Federation of Bosnia and Herzegovina Ltd. Mostar (hereinafter: JP Autoceste FBiH) was founded in accordance with the Law on Roads of the Federation of Bosnia and Herzegovina, and as a public company entity it operates since 01 January 2011. The activities of the JP Autoceste FBiH are defined by the Law on Roads of the Federation of Bosnia and Herzegovina, based on which JP Autoceste FBiH became the carrier and implementer of completion of a very complex and important project, construction of a part of international motorway Corridor Vc which connects Eastern and Central Europe with the Mediterranean coast. The legal framework for the activities of the Company, apart from the Law on Roads, consists of the Law on Motorway on the Corridor Vc, the Law on Companies in FBiH and other positive regulations in Bosnia and Herzegovina.

At the second Pan-European Conference on Transport held on Crete in 1994, the European Union defined its priorities in terms of infrastructure, and transport corridors toward the East, to be implemented by 2015. At the third Pan-European Conference held in Helsinki in 1997, the number of corridors was increased to ten and amendments were made. One of those amendments includes the introduction of Corridor Vc (Budapest – Osijek – Sarajevo – Ploče) into the basic European transport network.

Corridor Vc is a multi-modal road corridor that connects Hungary (Budapest) and Croatia (Ploče harbour), via Osijek (Croatia) and Sarajevo (Bosnia and Herzegovina), making it the largest transport infrastructure project in Bosnia and Herzegovina with a total length of 320 km, while the route of 273 km is passing through the Federation of Bosnia and Herzegovina. The construction of the motorway on Corridor Vc improves connection of BiH with the neighbouring countries and improves potentials for economic development. The project is strongly supported by the Government of the Federation of Bosnia and Herzegovina, and it is expected that it will enable Bosnia and Herzegovina a better integration with the European economic and social structures in Europe.

A total of 112.50 km of the motorway on Corridor Vc has been constructed and put into use, and it includes the following sections:

- Svilaj Odžak
- Zenica bypass (includes part of the sub-section Zenica Tunnel Donja Gračanica, subsection Klopče - Donja Gračanica and sub-section Drivuša – Klopče)
- Zenica South Sarajevo North
- Sarajevo North Sarajevo West
- Sarajevo West Tarčin
- Zvirovići Bijača.

The following pages of this report contain information about the dynamics of the project implementation under the jurisdiction of the JP Autoceste FBiH d.o.o. Mostar ending with September 30, 2022.

2. LOAN AGREEMENTS

Pursuant to the Law on Roads FBiH, funds for maintenance, protection, renovation, reconstruction and construction of motorways in FBiH are provided from:

- public revenues (income from excise duties, toll fees, income from the utilisation of road land);
- loans;
- donations (grants).

Bosnia and Herzegovina signed loan agreements with international financial institutions for the purpose of constructing sections of the motorway on Corridor Vc in the Federation of Bosnia and Herzegovina. In the period from 2008 until 2020 agreements with the European Investment Bank, European Bank for Reconstruction and Development, OPEC Fund and Kuwait Fund for Arab Economic Development were signed. Basic data about all signed loan agreements for the purpose of motorway construction on Corridor Vc are provided in three tables below:

The Government of the Federation of BiH passed the Decision on Approval for signing the Mandate Letter for financing of the motorway section on Corridor Vc Ovčari – Tunnel Prenj – Mostar North. In July 2021, the management of the JP Autoceste FBiH the Decision on submission of the Request for loan for the purpose of financing of construction works on motorway section from Ovčari to Mostar South. The Government of FBiH in October 2021 by their conclusions supported the loan initiative in the amount of 300 million EUR with EIB and EBRD. The Council of Ministers also adopted the above-mentioned loan initiatives.

2.	Mostar North - Mostar South	200 mil. EUR

Creditors: EBRD and commercial banks

Following the Decision on Approval of the Government of FBIH in March 2021, the Mandate Letter EBRD for section Mostar North – Mostar South was signed. JP Autoceste FBiH in July 2021 submitted a Loan Request for the purpose of construction works of the motorway section Ovčari – Mostar South. The Government of FBiH in October 2021 by their conclusion supported the loan initiative in the amount of 50 million EUR with EBRD.

JP Autoceste FBiH in December 2021, with assistance of procurement consultant provided by EBRD, announced a tender for bank debt with commercial banks in the amount of up to 150 million EUR, and the remaining funds will be provided by loans from commercial banks.

The first procedure of public procurement of commercial banks with the assistance of procurement experts of EBRD was not successfully completed. Taking into consideration the period of time and significant increase of the estimated value of the project because of the movement of prices at the global market, a new structure of funding of the project was adopted. It includes increase of the EBRD funds from 50 million EUR to 110 million EUR, i.e. potentially 220 million EUR. In accordance with the new structure of funding, a Request for loan was updated. Tender for procurement of commercial debt was published again on 29 June 2022. Draft of grant application for EU funds was also submitted.

3.	Vranduk – Ponirak additional debt	25 mil. EUR

In September 2019, the FBiH Ministry of Finance provided a negative opinion for the initiative for additional debt by instructing to find more suitable sources of financing. In March 2021 OFID delivered a letter of intention with updated terms of loan. In July 2021, JP Autoceste FBiH submitted an updated loan request under new, more suitable conditions. The Government of FBiH by its Conclusion from September supported the initiative for additional debt. The Council of Ministers of BIH adopted the initiative of the Ministry of Finance and Treasury in December 2021 and appointed the delegation for negotiations for the purpose of signing the Loan Agreement. The final draft of the Loan Agreement was delivered for adoption to the Council of Ministers. The signature of the Loan Agreement is expected after the Presidency of BiH appoints the authorised signatory on behalf of Bosnia and Herzegovina. Activities related to the signature of the Loan Agreement are in progress.

JP Autoceste FBiH submitted to the FBiH Ministry of Finance and FBiH Ministry of Traffic and Communications a Request for additional bank debt with Kuwait Fund in the amount of 21 million EUR. The Government of FBiH supported the initiative for provision of additional loan funds to be provided by Kuwait Fund for construction works on section Nemila –

Vranduk. The Council of Ministers of BIH in December 2021 adopted the initiative of the Ministry of Finance and Treasury and appointed delegation for negotiations for the purpose of signing the Loan agreement. Delivery of the Loan Agreement Draft from creditor is expected to be completed.

5. Ivan - Ovčari 162 mil. EUR

Creditors: EIB

Request for a loan in the amount of 162 million EUR (i.e. 50% of the project expenses) was submitted in September 2022, pursuant to the draft of Feasibility study from June 2022 in which a new estimate value of the sub-section in the amount of 324 million EUR was stated.

EIB will also support application for investment grant of WBIF up to 40% of the estimated value of project expenses. JP Autoceste FBiH will send inquiries to other international financing institutions in order to complete the financial construction of the project with the remaining expenses of 10%.

6. Ponirak – Vraca additional debt 7.5 mil. EUR

Creditors: EIB

Project solution and building permit were amended, making the length of section Ponirak – Vraca was enlarged to 3.90 km, and the length of the tunnel Zenica was enlarged to 3.50 km. Analysis of additional expenses for completion of the project and evaluation of expenses of construction works requires additional 14.3 million EUR, and the services of supervision requires additional 0.60 million EUR. The missing funds in the amount of 7.40 million EUR cannot be financed exclusively by JP Autoceste FBiH, and therefore in September 2022 a Request for additional bank debt in the amount of 7.50 million EUR was submitted.

3. EU GRANTS

JP Autoceste FBiH d.o.o. Mostar as the final user of the loans from European banks also applies for pre-accession grants of the European Union (Connectivity Agenda) which are implemented through the Western Balkans Investment Framework. Until the middle of 2022, the EU approved over 300 million EUR grants for Corridor Vc in the Federation of BiH. Funds are implemented through a creditor which finances the construction of the section (EIB or EBRD). If the grant is implemented through EBRD different Investment Grant Agreements are signed (between EBRD and BiH) and Technical Assistance Grants (one is signed between EBRD and JP Autoceste FBiH). If the grant is implemented through EIB, then one Grant Agreement is signed covering both components. Below is the status of grants that were approved for motorway sections on Corridor Vc.

Ratification procedure will be completed after the Decision is made by the Presidency of BiH. The Government of FBiH made Decision on issuing an approval for acceptance of the investment grant in September 2022.

Technical Assistance Grant Agreement in the amount of 5.05 million EUR was signed between EBRD and JP Autoceste FBiH on 2 August 2021. EBRD refunded funds in February 2022 for TA component and continued with direct financing of supervision expenses.

Investment Grant Agreement in the amount of 9.2 million EUR was signed in March 2021. The Presidency of BiH made Decision on ratification in July 2021, and the Agreement on sub-grant was signed in the same month. In March 2022, a notification from the bank about the effectiveness of Grant Agreement was received after which EBRD completed a refund of the funds owned by the JP Autoceste FBiH and continued with payment of construction expenses.

Technical Assistance Grant Agreement in the amount of 2.80 million EUR was signed between EBRD and the JP Autoceste FBiH on 2 August 2021. EBRD refunded funds in February 2022 for TA component and continued with direct financing of expenses.




Chart 1. Procurement plan

5. LOTS ON CORRIDOR Vc




The Corridor Vc in BiH includes four main sections, referred to as Lots in the official documents and they are distributed from North to South, as below:

- Lot 1: Svilaj on the Sava river Doboj South;
- Lot 2: Doboj South Sarajevo South (Tarčin);
- Lot 3: Sarajevo South (Tarčin) Mostar North;
- Lot 4: Mostar North Bijača at the southern border with Croatia.

The following pages of the Report according to the above-mentioned LOTs shows the progress on sub-sections that are being prepared or under construction.

5.1. LOT 1: SVILAJ - KARUŠE



LOT 1 starts with section Svilaj – Odžak which was released for use on 30-Sep-2021. Motorway sections from Odžak to the Tunnel Putnikovo brdo are under the jurisdiction of JP Autoputevi RS, which is followed by a sub-section Putnikovo brdo – Medakovo. Although one part of the subsection Putnikovo brdo – Medakovo (from Karuše to Medakovo) belongs to the LOT 2, data will be shown in this chapter.

SECTION SVILAJ – ODŽAK

TECHNICAL DESCRIPTION

Total length of the section is 10+400 km. Initial point of the section is the Bridge Svilaj, followed by a 300 m long section until the border crossing Svilaj, after which there is the Interchange Svilaj. Further on there is the frontal toll booth Svilaj. The section ends at the Interchange Odžak which is situated near Odžak. Implementation of the project is divided in two phases, because of the harmonisation with the dynamics of bridge construction over the Sava river. Construction of this section connects parts of the Corridor Vc in Croatia and Bosnia and Herzegovina.

SECTION PUTNIKOVO BRDO - MEDAKOVO

TECHNICAL DESCRIPTION

The section is 8.5 km long. The route starts at the exit of the tunnel Putnikovo brdo 2 at the border between two entities. It extends further toward the intersection Usora where a sideway toll booth is situated, after which the route passes over the bridge constructed over the regulated riverbed of the Usora river and over the bridges it reaches Karuše. In Karuše, the route passes through a hill, and on that location a 220 m long cut&cover system is planned. The route passes further through the places Tešanjka, and Medakovo as well as unpopulated areas. The section ends after the intersection Medakovo.

FINANCING

EBRD, agreement number 50603 EU grant number WB-IG04-BIH-TRA-01

PROJECT DOCUMENTATION

End of September 2020 a preparation of an innovated main design for sections Putnikovo brdo – Karuše and Karuše – Medakovo was completed.

APPROVALS AND PERMITS

In June 2016, the Federal Ministry of Environment and Tourism issued the Decision on renewed environmental permit for a complete LOT1 Svilaj – Doboj South (Karuše), whereas in September 2019 they issued environmental permit for a complete LOT2 Doboj South (Karuše) – Sarajevo North.

In September 2021, the Federal Ministry of Spatial Planning issued the Decision on urban permit for a complete section Putnikovo brdo – Medakovo.

Request for issuing of Building permit was submitted in July 2022. The processing of the request is in its final phase.

EXPROPRIATION

The route of this section passes through municipalities Tešanj, Doboj Jug, and Usora, and expropriation procedure was initiated in all the above-mentioned municipalities. In the Tešanj Municipality of 332 subjects, 326 subjects were completed. In the Usora Municipality of 133 subjects, 111 subjects were completed. In the Doboj Jug Municipality 76 subjects were completed. 99.07% of the surface area included in the expropriation study was expropriated.

PROCUREMENT - SERVICES

Services of contractors

Type of procedure: Open procedure with pre-qualification

Pre-qualification procedure was completed in January 2022, when the Bank issued its approval on evaluation report of the first phase. Evaluation of offers in the second phase was completed. The report was prepared and sent to the Bank for their approval in July 2022. The Bank issued their approval on the evaluation report for the second phase on 22.07.2022. It is estimated that the agreement could be signed in the fourth quarter of 2022.

Services of supervision

Type of procedure: Competitive

Invitation for expression of interest was announced in October 2020, and the deadline for application submission was December 2020. Evaluation report was completed and sent to the Bank for their approval, which was delivered in February 2022. Invitation for submission of technical offers was announced in April 2022, evaluation of technical offers was completed and Bank's approval of the report was received in June 2022. Opening of financial offers was held on 02.07.2022 and preparation of the revised financial report is in progress. It is estimated that the agreement for the services of supervision could be signed in the fourth quarter of 2022.

5.2. LOT 2: KARUŠE - TARČIN



145 km long LOT 2 is the longest LOT on the Corridor. It consists of sections from Doboj South until Sarajevo South (Tarčin). The largest part of LOT 2 consists of already constructed motorway section (Zenica North – Zenica South and Zenica South – Tarčin) which is already in use and in the system of toll payment, with a length of 92.9 km. The Zenica bypass (Zenica North – Zenica South) which consists of sub-section Drivuša – Klopče, Klopče – Donja Gračanica and part of the section Tunnel Zenica – Donja Gračanica was released for traffic on 15 July 2021. Other sections on this LOT are in the preparatory phase or under construction which is shown in the following pages of this chapter. Information on motorway part from Karuše to Medakovo are shown in the previous chapter, and we start this chapter with the section Medakovo – Ozimice

SECTION MEDAKOVO - OZIMICE

TECHNICAL DESCRIPTION

The length of the section according to the main design is 21.7 km. Starting point of the section is located after the intersection Medakovo, and the next approx. 10 km of the route passes mainly through settlements: Medakovo, Alispahići, N.Šeher, Ljubatović. The route also contains a tunnel with the approximate length of 2200 m and rest area from both sides. After exiting the tunnel, the route is laid to the south. Afterwards, the route passes around borders of small settlements and comes to the interchange Ozimice where the subject section ends.

FINANCING

EIB, agreement number 91.682

EU grant, application submitted in the Sixth WBIF invitation. Application was positively graded.

PROJECT DOCUMENTATION

Main design and revision of the main design were completed.

APPROVALS AND PERMITS

In September 2019, the FBiH Ministry of Environment and Tourism issued the Environmental permit for the complete LOT 2 Doboj South (Karuše) - Sarajevo North.

Urban permit was obtained.

Building permit will be obtained after fulfilment of the legal requirements, including revised main design and finalised procedure of expropriation.

EXPROPRIATION

The route of this section passes through Tešanj Municipality, Maglaj Municipality and Žepče Municipality. Expropriation procedure is in progress. The characteristic of this section is a large number of residential buildings that need to be expropriated.

In Tešanj Municipality it is necessary to expropriate totally 704 land lots, of which 485 lots have been expropriated up until now. Concerning the number of subjects, of the total 404 subjects, 311 subjects have been completed so far. A total of 65.82% of the surface area included in the expropriation study was expropriated.

In Maglaj Municipality it is necessary to expropriate 220 land lots. Of the 112 cases formed in the administrative procedure, 74 cases have been completed until now. 63.72% of the surface area included in the expropriation study was expropriated.

Expropriation procedure in Žepče Municipality includes 326 land lots. In cadastral municipality Ljubatovići, of the total 74 cases, 59 cases have been completed. The preparation of the expropriation cases for cadastral municipality Goliješnica is in progress. In cadastral municipality Ozimica until now 14 expropriation cases have been completed.

PROCUREMENT - SERVICES

Services of contractors

Type of procedure: Open procedure without pre-qualification

Preparation of tender documentation was completed and the Bank's approval of the tender documentation was delivered on 09 June 2022. On the same day, the invitation for submission of offers with deadline for submission until 16 August 2022 was published. Evaluation of offers was completed; evaluation report of Phase II was delivered to the bank on 24 August 2022. The Bank provided approval on technical evaluation report on 29 August 2022.

Services of supervision

Type of procedure: Competitive

Invitation for expression of interest was announced at the end of February 2022, and the deadline for application submission was mid of April 2022. Evaluation of applications was completed and sent to the Bank for their evaluation report, which was delivered in May 2022. Invitation for offer submission was announced in June 2022, and the deadline for offer submission was 28 July 2022. Evaluation of technical offers was completed; technical evaluation report was sent for the Bank's approval on 12-Sep-2022.

Technical Assistance Services for PIU Medakovo - Poprikuše

Public procurement procedure is in its final phase. Bank's approval of the final evaluation report was delivered on 03 August 2022. Signature of the agreement with the selected tenderer is expected in the next quarter.

Services Biodiversity for the section Medakovo - Poprikuše

Type of procedure: Direct

Evaluation of offers was completed. Agreement in the amount of 40,000.00 EUR without VAT, i.e. 46,800.00 EUR with VAT included was signed with Zagrebinspekt Ltd. Mostar.

Services Revision of road safety (RSA) for the section Medakovo - Poprikuše

Type of procedure: Direct

Evaluation of offers was completed. Agreement in the amount of 49,240.00 EUR without VAT, i.e. 57,610.80 EUR with VAT included was signed with Ecoplan Ltd. Mostar.

SECTION OZIMICE - POPRIKUŠE

TECHNICAL DESCRIPTION

The section is 12.8 km long. The section from Ozimice to Tatarbudžak is in the corridor of the route that was previously approved by the local community. From Tatarbudžak, the route descends to the area of the settlement Šećin Han between the corridor of the route of the main road and railway from one side and riverbed of the Bosna River from the other side. Further, the route follows mainly that corridor until the starting point of the next section Poprikuše – Zenica North. The route affects settlements Varišište, Šećin Han, Brezovo polje and ends in Golubinja. Intersection Poprikuše is planned at the very junction of the two sections. On this route, a total of 10 bridges are planned, and larger and more demanding structures are planned over the riverbed of the Bosna river, main road and railway. This route also includes four tunnels and one rest area.

FINANCING

EIB, agreement number 91.682

EU grant, application submitted in the Sixth WBIF invitation, but due to the level of project readiness, the application submission will be repeated in the next WBIF invitation.

PROJECT DOCUMENTATION

Preliminary design was completed. Agreement for procurement of the main design was signed on 05 October 2021. The predicted period of contract is ten months. The preparation of the main project is in progress. The period was extended for architect because of problems with access to the location of a drill site.

APPROVALS AND PERMITS

In September 2019, the FBiH Ministry of Environment and Tourism issued the Environmental permit for the complete LOT 2 Doboj South (Karuše) - Sarajevo North.

Request for issuing the urban permit will be submitted after the selected Architect who is in charge for preparation of the main design unites and completes the previously completed project documentation together with the new one, with the aim of unobstructed obtaining of all permits.

Building permit will be obtained after fulfilment of the legal requirements, including revised main design and finalised procedure of expropriation. Preparation of the main design is in progress.

EXPROPRIATION

Expropriation procedure on the basis of the available expropriation studies for 6.2 km of the route was initiated in Žepče Municipality. Of the 279 land plots in 4 cadastral municipalities in Žepče, 220 land plots have been expropriated, which is a percentage of 57.36% of totally expropriated surface area included in the expropriation study for the first part of this section.

PROCUREMENT - SERVICES

Services of contractors

Type of procedure: Open procedure with pre-qualification

Decision on procedure initiation was made in April 2022. Pre-qualifying documentation was sent to the Bank for approval in July 2022. Currently, adjustment of amendments of the pre-qualifying documentation is in progress.

Services of supervision

Type of procedure: Competitive

Decision on procedure initiation was made in April 2022. Invitation for expression of interest was announced in May 2022, and the deadline for application submission was 06 July 2022. Evaluation of applications was completed; evaluation report was sent to the Bank in August 2022. Bank's approval of the evaluation report was delivered at the beginning of September 2022.

SUB-SECTION POPRIKUŠE – NEMILA

TECHNICAL DESCRIPTION

The section starts close to the settlement Poprikuše, souther from town Žepče. The route starts with the bridge over the Bosna river, intersection Poprikuše, continues over the viaduct over the main road M17, and enters the tunnel Golubinja with a length of approx. 3.5 km. After exiting the tunnel Golubinja, the route again crosses the main road M17, and the Bosna River over the bridge with length of approx. 220 m, and railway over the viaduct with a length of approx. 110 m. After the above-mentioned viaduct, the route ends and joins the next section. The total length of this route is approx. 5.5 km.

Current challenges related to the project implementation and undertaken measures

Challenges:

Excavation of the tunnel and primary construction:

Current geological conditions are very demanding, and for stabilisation the strongest structural support system is used. Change of deformation (convergence) in the tunnel is up to 20 centimetres. On the basis of these data it can be concluded that the tunnel is at the bottom of the scale of construction capabilities according to NATM regulations.

Material procurement:

Supplier currently does not have problems with procurement of materials that might be caused by the war in Ukraine. Problems that occur are caused by the constant and enormous growth of prices, so that certain suppliers are not able to deliver ordered materials.

Undertaken measures:

Works on the primary construction and excavation of the tunnel are performed in accordance with the predicted geological conditions and project documentation.

Problems with material procurement do not influence the dynamics of works, as the Contractor has agreements with several suppliers, and the payment is mainly done in advance.

Challenges related to the price escalation:	Total price escalation until 30 th September is in amount of EUR 18.048.834,04. Estimated price increase escalation until project completion is up to 40,40%.

ACTIVITIES AT THE CONSTRUCTION SITE IN THE REPORTING PERIOD

Description of performed works

In the previous reporting period, preparatory and permanent works on construction of motorway route and re-location of the main road M17 are performed including cleaning of the terrain, destruction of the constructions on the route, cutting of the forest, geo-research works, and excavation and filling on the large portion of relocated main road M-17 and partially on the motorway route.

Contractor builds AB constructions of underpasses ("Nemila North" and "Rest area") as well as plate and tube culverts under the trunk of the motorway and relocated main road. AB constructions of sustaining wall M17-1 and M-17-3 are built by building base on piles, which are placed along the riverbed of the Bosna River. AB works are performed on the construction of the regulation of the riverbed of the Nemila river.

Also, the contractor works on a temporary regulation of the riverbed of the Bosna River, by re-directing and building of groynes to perform their activities in dry conditions.

In parallel with ground and concrete works, the following works are performed: relocation, protection and construction of various utility constructions.

The preparation of the missing project and agreement documentation is in progress (main design, implementation projects, geo-technical missions etc.)

Current challenges related to the project implementation and undertaken measures

Challenges: Works are performed near the existing main road with increased traffic.

Undertaken measures: Study of temporary traffic regulation was made, based on which the approval from the competent Ministry was obtained. Construction zones are properly marked by traffic equipment and signalisation.

Challenges: Construction works are planned to be performed closely to the residence buildings (houses) in the area of settlement Stara Stanica.

Undertaken measures: There were conversations and meetings with the local population and informing about the construction works. Construction zone marking was completed, and competent engineer completed the analysis and recommendations for solving and working on this location.

Challenges: Works on the regulation of the Bosna River through Nemila were planned. It is one of the largest water-courses in Bosnia and Herzegovina which often overflows and causes floods on this location.

Undertaken measures: The main design of the regulation of the Bosna River with all the necessary technical solutions and measures for protection from flooding of the hundred-year-old water courses.

Challenges related to the price escalation:	Total price escalation until 30 th September is in amount of EUR 293.895,19. Estimated price increase escalation until project completion 20% of contracted value of works.

Structures on this route include bridges Vranduk 1 and Vranduk 2, which are built using the technology of cantilever construction and tunnel Vranduk, as well as three small viaducts. ACTIVITIES AT THE CONSTRUCTION SITE IN THE REPORTING PERIOD

Description of performed works

Route: Sector 4a (with the length of 920 metres) completion of works according to the new design. In the previous three months, there are more active works on drain systems, drainage pipes, excavation of canals, and preparation of the central collector point for internal drainage.

Works on sector 5 (138 metres) are being performed according to the new design. In the previous period, most of the time was dedicated to the excavation works, by mining and protection of the slope. Currently, there are preparatory works on excavation of the fifth slope (of 6 designed). Installation of shotcrete, reinforcing mesh, anchors and MacMat mesh.

Sector 2 – In the previous period, material was excavated and the first floor of the slope secured with 6 metres IBO anchors, shotcrete and reinforcing mesh. Works on the drainage of the first floor.

Preliminary designs for sectors 1, 6 and 7 were obtained, and the main designs for the Koprivna Viaduct 2 and sector 6 are expected to be delivered soon. It is expected that works on these parts of the route are to begin until the end of the year.

Landfills:

Boški Potok: Currently not used

Maliniak 1 is filled.

The following landfills are also active: L9. The rest of the L landfills are in the process of closing.

The project of the new landfill Malinjak 2 with the sufficient capacity to receive excavated material from the entire section was completed. The next step is cutting down the forest and opening a landfill.

Tunnel Vranduk: Works on the gallery of approach cutting of the southern portal of the right pipe.

Bridge Vranduk 1: Preparation of the construction of this structure was completed. Asphalting of all constructions, waterproofing and drainage elements on all constructions per request of contractor and approval of the purchaser is prolonged. This prolonging will not influence further construction works, because on other parts of the section there are delays.

Bridge Vranduk 2: Preparation of the construction of this structure was completed

Viaduct Crni potok: Preparation of the construction of this structure was completed

Viaduct Koprivna 1: Preparation of the construction of this structure was completed. Construction works on the bridge Koprivna 2 did not start yet due to the unsolved issue of construction of sectors 6 and 7 which is positioned between these two.

ACTIVITIES AT THE CONSTRUCTION SITE IN THE REPORTING PERIOD

Description of performed works

In the reporting period from 01.07.2022 until 30.09.2022 the Contractor continued their activities from the previous period:

- Works on reparations of the primary sub-construction.
- Works on installation of final shotcrete on corrected sections
- Works on installation of waterproofing elements
- Works on installation of the sideway drainage and secondary revetment.

These works are completed in the right tunnel pipe, and currently they are performed in the left tunnel pipe.

Current challenges related to the project implementation and undertaken measures

Challenges:

- 1. Everyday price growth on the global and local markets cause large price escalations included in the contract, which will further increase the overrun of the contracted budget. Price escalation can only be estimated due to the unpredictable situation on the market.
- 2. The progress of the works is still not satisfactory. The Contractor did not prepare Executive Projects for the phases after the completion of the secondary lining, nor submitted requests for the approval of subcontractors for phases for which they are not authorised (electrical and mechanical works), nor requests for the approval of a large number of materials for these phases. Part of the material is made to order and delivery takes several months. It is already questionable whether the Contractor will fulfill all contractual obligations until 08.05.2023.

Undertaken measures:

Since the beginning of the year, the engineer has repeatedly warned the Contractor about the risks under point 2, but the Contractor did not undertake the appropriate activities. The Contractor must mobilise more resources and improve organisation of the construction site in order to complete the full scope of working activities within the stipulated period.



SUB-SECTION IVAN - OVČARI

TECHNICAL DESCRIPTION

The section starts immediatelly after the Ivan Tunnel portal. Most of the route is in bridges and tunnels (12 bridges with a total length of 3.6 kilometres and 6 tunnels with a total length of 3.6 kilometres) and passes through the settlements: Vrbljani, Badanj, Gajevo Bradina and Zukići and ends with a temporary connection to the main road M17 in Ovčari.

FINANCING

Not defined. The section is included in the Programme of Public Investments of the Federation for the period 2021 - 2023, which is a pre-condition for starting of the debt procedure with international financial institutions. The EIB delivered a Letter of Intent to finance this section.

PROJECT DOCUMENTATION

WBIF grant funds were secured for the preparation of the main design. The ToR for the main design was agreed between IFICO, EUD, and IFI. IPF 9 is responsible for the grant implementation, that is, for the preparation of project documentation: Feasibility study, Environmental impact study, Preliminary design, Main design and revision of the main design.

The preparation of the preliminary design is in the final phase, after which, upon approval of the extension of the requested funds by the bank, the preparation of the main project will be continued.

The preparation of study and project documentation is in progress, and the planned completion for the preparation of documentation at the level of the main design is in the course of Q4 2023.

APPROVALS AND PERMITS

Urban permit was previously obtained for the part of the route that was not changed.

EXPROPRIATION

The expropriation procedure will be initiated after the declaration of public interest by the Government of the Federation of Bosnia and Herzegovina.

PROCUREMENTS

The procurement procedure will be initiated according to the creditor's rules after the conditions for initiating the procedure are met

SUB-SECTION OVČARI – (ENTRANCE TO TUNNEL) PRENJ

TECHNICAL DESCRIPTION

The section starts with the M1 bridge above the intersection in Ovčari, on the slopes of the right side of the main road M17 and continues further with the bridge that crosses the main road and the Trešanica river. There are 7 bridges and 2 tunnels on this section, the most important of which are: the viaduct over the Industrial Zone and the 2.2-kilometre-long tunnel on the eastern side of Konjic, as well as the bridge over the Neretva River.

FINANCING

JP Autoceste FBiH submitted a request in July 2021 for debt for sections from Ovčari to Mostar South. The EU grant application will be prepared when the project documentation is in the final phase

PROJECT DOCUMENTATION

Preliminary design completed. For the sections Ovčari - Entrance to the Prenj tunnel and Exit from the Prenj tunnel - Mostar North, WBIF grant funds were secured for the preparation of project and study documentation. These two grants are implemented together in two components:

- Component 1: includes a Gap analysis, environmental impact study and a package of environmental and social documents in accordance with EBRD standards. The start of the study was in June 2020. The preparation of documentation is in progress, including the performance of hydrogeological research. The preparation of the study is in the final phase. On the section Ovčari Entrance to the Prenj tunnel, the surveying of the terrain and the creation of new geodetic foundations were completed. The demining of the terrain on the part that was contaminated with mines and explosives was completed. The geo-research works for the needs of the G1 mission were completed and the preparation of the study is in progress in order to continue the execution of the G21 mission. The designer is currently working on the disposition of the facilities, while the continuation of the main design is expected after the Bank's approval of the requested IPF funds.
- Component 2 includes the main design and tender documentation, and work on the preparation of this part
 of the documentation began in Q1 2021. Q2 2023 is the deadline for completion of the design documentation
 for Component 2. IPF 8 is in charge of implementation.

APPROVALS AND PERMITS

The validity of the previous water permit was extended. The consents of BH GAS and the necessary electrical permits have been obtained. The Consultant prepared a Request for a Preliminary Environmental Impact Assessment and submitted it to JP Autoceste FBiH in February 2022. The request for a Preliminary Environmental Impact Assessment for the section of the highway on the Corridor Vc Konjic (Ovčari) - Prenj Tunnel - Mostar North was submitted to the Federal Ministry of Environment and Tourism and the prepared study documentation was made available for public inspection. In April 2022, a decision that determines the content and scope of the Environmental Impact Study was issued, and the preparation of the study is currently in progress. Completion of the Study is in its final phase. The urban permit will be obtained after the correction of the preliminary design and obtaining of the approval of the environmental impact study.

EXPROPRIATION

In June 2022, the Government of the Federation of Bosnia and Herzegovina adopted the Decision on the declaration of public interest for the construction of the motorway section Konjic - Tunnel Prenj on the Vc Corridor.

PROCUREMENT

The procurement procedure will be initiated according to the creditor's rules after the conditions for initiating the procedure are met

SECTION TUNNEL PRENJ

TECHNICAL DESCRIPTION

The key feature of the tunnel Prenj is its length of 10.15 km according to which it belongs to long tunnels and is subject to the application of all prescribed safety measures in tunnels, according to Directive 2004/54/EC. With the exception of the Prenj Tunnel, this section implies access to the northern and southern portals of the Tunnel.

FINANCING

EIB and EBRD, initiative for debt is in progress

JP Autoceste FBiH in July 2021 submitted a request for debt for sections from Ovčari to Mostar South.

For the EU grant will be applied in the Seventh WBIF invitation during 2022

PROJECT DOCUMENTATION

Preliminary design was completed in 2016. The procurement of preliminary design services with elements of the Main design was announced in December 2021.

The main design will be prepared by the Contractor since it is planned that the project will be realised according to the FIDIC Yellow Book. As part of the G1 mission, the following were prepared:

- Report on engineering, geological, hydrogeological and geotechnical investigation works for the Prenj tunnel, WINNER PROJECT Ltd. Sarajevo, 2016
- Preliminary geotechnical project for the tunnel Preni

In cooperation with external collaborators, a Programme of additional investigative works was drawn up. The implementation of the part of the Programme related to hydrogeological research and trial IG mapping and research from the Programme of additional investigative works is in progress.

In cooperation with CTP Zagreb, a project task was drawn up for the preparation of Quantitative Risk Analysis and accompanying studies (Ventilation Study, Risk Assessment Study for Hazardous Materials Transportation, Fire Risk Assessment Study). Financing and preparation of the Risk Analysis and accompanying studies will be realised through the fund implemented by the European Union Technical Assistance Programme - Connecta. The preparation of the analysis and accompanying studies was completed in the second quarter of 2021, and the preparation of additional reports and documentation is in progress.

A consulting contract was signed for the application of fire safety measures - Prenj Tunnel

APPROVALS AND PERMITS

The validity of the previous water permit was extended.

The consultant prepared a Request for a Preliminary Environmental Impact Assessment for the motorway section on the corridor Vc Konjic (Ovčari) - Tunnel Prenj - Mostar North and delivered it to JP Autoceste FBiH in February 2022. The request for a Preliminary Environmental Impact Assessment for the motorway section on the Corridor Vc Konjic (Ovčari) - Tunnel Prenj - Mostar North was delivered to the Federal Ministry of Environment and Tourism, and the study documentation was made available for public inspection. In April 2022, a decision was issued that determines the content and scope of the Environmental Impact Study, and the study is currently under construction. The expected deadline for the completion of the Study is Q4 2022.

The urban permit will be obtained after the correction of the preliminary design and the decision on the approval of the environmental impact study.

EXPROPRIATION

In July 2020, the Government of the Federation of Bosnia and Herzegovina passed a Decision on the declaration of public interest for the construction of the Prenj Tunnel section of the Vc Corridor. Studies for the expropriation of the access roads toward the tunnel portals, both north and south, were delivered.

In July 2022, a public advertisement was announced for the mutual acquisition of real estate, after the expiration of which the requests for division of the plots, the proposals for expropriation with the associated studies were delivered to the competent local government units of the City of Mostar and the City of Konjic.

PROCUREMENT ACCORDING TO THE INTERNATIONAL PROCEDURES

PROCUREMENT - SERVICES

Preparation of the preliminary design with the elements of the main design

Type of procedure: Open

The public procurement procedure is in its final phase. The Bank's approval of the final evaluation report was delivered on 12-Sep-2022. The signing of the agreement with the selected bidder is expected in the next quarter.

Technical assistance during the tendering process for procurement of works and supervision and monitoring of environmental and social issues

Type of procedure: Competitive

The management of JP Autoceste FBiH made the Decision on initiating of the procedure in January 2022. The invitations for expressions of interest were published in July 2022. The evaluation of the received applications was completed, and the evaluation report was sent to the Bank for their approval on 24-Sep-2022.

Preparation of the preliminary design and main design for preparatory works and preparation of the tender documentation

Type of procedure: Competitive

The public procurement procedure ended with the signing of the agreement on 13.05.2022 with JV: Design & QC Ltd. Sarajevo and IPSA Institute Ltd. Sarajevo in the amount of EUR 578,402.00 EUR - without VAT, i.e. 676,730.34 EUR with VAT included.

Contractor for construction of access roads

Type of procedure: Open

The decision to initiate the procedure was made in July 2022. The tender documentation was completed and the Bank's approval of TD was delivered on 21-Sep-2022. The invitation for offers was published on 21.09.2022, and the due date for submission of offers is 21-Nov-2022

Supervision services of the construction of access roads

Type of procedure: Competitive

The decision to initiate the procedure was made in July 2022. The tender documentation was completed and the Bank's approval of TD was delivered on 21-Sep-2022. The invitation for offers was published on 12-Sep-2022, and the deadline for offer submission is 27-Oct-2022

Construction works services

Type of procedure: Open with pre-qualification

The decision to initiate the procedure was made on 06 July 2022. Bank's approval of the pre-qualifying documentation was delivered on 12 July 2022. Approval of the publishing of the pre-qualifying documentation was delivered on 14 July 2022. Publishing of the pre-qualifying documentation for the Tunnel Prenj was on 14 July 2022. The deadline for offer submission is 26-Sep-2022.

Supervision services of the construction of the Tunnel Prenj

Type of procedure: Competitive

The documentation for the invitation for expressions of interest is currently being prepared.

SECTION EXIT FROM THE TUNNEL PRENJ - MOSTAR NORTH

TECHNICAL DESCRIPTION

The section, approximately 13 kilometres long, passes entirely through the Herzegovina-Neretva canton. Among the structures on the motorway route, there is an 800 m long tunnel, three viaducts between 300 and 400 metres long and a 2.2 km long tunnel at the end of the route. This section (as well as the section Ovčari - Prenj) is functionally connected and traffic conditioned by the construction of the Prenj Tunnel.

FINANCING

EIB and EBRD, initiative for debt is in progress

JP Autoceste FBiH in July 2021 submitted a request for debt for sections from Ovčari to Mostar South. For the EU grant will be applied when the preparation of the project documentation reaches its final phase

PROJECT DOCUMENTATION

Preliminary design completed. For the sections Ovčari - Entrance to the Prenj tunnel and Exit from the Prenj tunnel - Mostar North, WBIF grant funds were secured for the preparation of project and study documentation. These two grants are implemented together in two components:

Component 1 includes a Gap analysis, environmental impact study and a package of environmental and social documents in accordance with EBRD standards. The start of the study was in June 2020. On the section in subject, geodetic and geoinvestigation works were completed in the past period, and the preparation of a Rockfall analysis by the designer is in progress, which will explain the safety aspects of the passage of the route in the area of the location Klenova Draga. The completion of the Rockfall analysis will be after the approval of funds for Component 2. Demining at the Šljeme location was completed and confirmed by BH - MAC.

Component 2 includes the main design and tender documentation, and work on the preparation of this part of the documentation began in Q1 2021. IPF 8 is in charge of implementation. Preparation of study and project documentation is in progress. Q2 2023 is the deadline for completion of the design documentation for Component 2.

APPROVALS AND PERMITS

The validity of the previous water permit was extended. The permits of BH GAS, Public Company Railways FBiH and the necessary electrical permits were obtained. The Consultant prepared a Request for a Preliminary Environmental Impact Assessment for the motorway section on the Corridor Vc Konjic (Ovčari) - Tunnel Prenj - Mostar North and submitted it to JP Autoceste FBiH in February 2022. The Request for a Preliminary Environmental Impact Assessment for the motorway section on the Corridor Vc Konjic (Ovčari) - Tunnel Prenj - Mostar North was delivered to the Federal Ministry of Environment and Tourism, and the study documentation was made available for public inspection. In April 2022, a decision that determines the content and scope of the Environmental Impact Study was issued, and the study is currently being prepared. The expected deadline for the completion of the Study is Q3 2022.

Urban permit will be obtained after the correction of the preliminary design and the decision on the approval of the environmental impact study.

EXPROPRIATION

In June 2022, the Government of the Federation of Bosnia and Herzegovina made a Decision on the declaration of public interest for the construction of the motorway section of the Corridor Vc, Prenj Tunnel – Mostar North.

NABAVKE

The procurement procedure will be initiated according to the creditor's rules after the conditions for initiating the procedure are met

5.4. LOT 4: MOSTAR NORTH - BIJAČA



LOT 4 represents the southern part of the Corridor Vc. Three sections of this LOT are in the preparatory phase for implementation, two sections are under construction, while the section Zvirovići - Bijača with a length of 10 kilometres is in use and in the toll collection system.

SECTION MOSTAR NORTH - MOSTAR SOUTH

TECHNICAL DESCRIPTION

The length of the section is approx. 15 km. According to the preliminary design, the section includes the Mostar North interchange with a sideway toll booth, six tunnels with a total length of about 9 km and six relatively short viaducts/bridges with a total length of about 2 km. The length of the open route is about 4 km.

FINANCING

EIB and EBRD, initiative for debt is in progress

JP Autoceste FBiH in July 2021 submitted a request for debt for sections from Ovčari to Mostar South.

For the EU grant will be applied in the Seventh WBIF invitation during 2022

PROJECT DOCUMENTATION

The preliminary and main design were prepared earlier, but the motorway route was changed by the Spatial Plan of Special Features of Importance for the Federation - Motorway on Corridor Vc. Investigation works were completed for this section and a preliminary geotechnical mission G1 was prepared for the route adopted by the Spatial Plan. A renewed invitation for expressions of interest for the preparation of the Preliminary and Main Design was published on 24.12.2021, and a renewed invitations for expressions of interest for the audit services of the Main design was published on 27.12.2021. On 26.09.2022, the Agreement for the preparation of the Preliminary and Main design for the motorway section Mostar North - Mostar South was signed. The deadline for the completion of the contracted services is 9 months.

APPROVALS AND PERMITS

The preparation of the Environmental Impact Study and other documents according to the environmental protection and social issues policy of EBRD was financed with the grant funds of EBRD. Consulting house Enova Ltd. Sarajevo was hired to prepare the documentation. A complete environmental impact assessment procedure was completed according to the current law. A Decision on the acceptance of the Environmental Impact Assessment Study was obtained in May 2022.

The urban permit will be obtained after the environmental permit.

EXPROPRIATION

In July 2020, the Government of the Federation of Bosnia and Herzegovina made a Decision on the declaration of public interest for the construction of motorway section Mostar North – Mostar South on the Vc Corridor.

PROCUREMENT - SERVICES

Construction works services

Type of procedure: Open

The decision to initiate the procedure was made on 16 July 2022, and it was amended on 17-Nov-2021. The preparation of pre-qualifying documentation was completed, and the Bank delivered its approval of the pre-qualifying documentation on 22 July 2022. Invitation for pre-qualification was published on 01 August 2022, and the deadline for application deliveries is 17-Oct-2022.

Supervision services

Type of procedure: Competitive

The decision to initiate public procurement was made in December 2021. The invitation for expression of interest was published in May 2022, and the deadline for submission of applications was the end of June 2022. The evaluation of received applications was completed. The evaluation report was sent to the Bank for their approval on 24-Sep-2022.

Services of preparation of the preliminary and main design

Type of procedure: Competitive

The public procurement procedure was completed on 26.09.2022, by signing the agreement with JV: Yuksel Proje (Turkey), PPG Ltd. Sarajevo (BiH), Design & QC Ltd. Sarajevo (BiH), Integra Ltd. Mostar (BiH), Trasa Ltd. Sarajevo (BiH). Agreement value is 7,209,615.30 EUR without VAT i.e. 8,435,249.90 EUR with VAT included.

Services of revision of the main design

Type of procedure: Competitive

The public procurement procedure is in its final phase. The Bank's approval of the final evaluation report was delivered on 11-Aug-2022. The signing of the agreement with the selected bidder is expected in the next quarter.

SUB-SECTION MOSTAR SOUTH - TUNNEL KVANJ

TECHNICAL DESCRIPTION

The length of the section is 8.6 km. Of the structures on this section, two bridges and two double-tube tunnels stand out.

FINANCING

EBRD, agreement number 49058 (Tranche B)
EU grant, application submitted in the Sixth WBIF invitation

PROJECT DOCUMENTATION

Preliminary design completed. The procurement procedure for the main design was canceled due to the fact that the Government of the Federation changed the method of realisation of this project from the FIDIC Red Book to the FIDIC Yellow Book, which implies that the selected contractor creates the main design based on the investor's preliminary design.

APPROVALS AND PERMITS

Previous approvals for urban permit were obtained. In July 2020, the updated Environmental Impact Study, Waste Management Plan, Biodiversity Assessment, and other documents prescribed by the EBRD's environmental protection and social issues policy were finalised and made public. The public hearing, which is a pre-condition for issuing of an environmental permit, was held on 14 September 2020 in Mostar.

Federal Ministry of Environment and Tourism on 17.02.2021 issued a decision on the environmental permit. On 18.11.2021, a decision on the legal validity of the environmental permit was made.

A request for urban permit was submitted to the relevant ministry, and the request is currently being processed.

EXPROPRIATION

The city of Mostar is responsible for the expropriation procedure. The expropriation procedure was initiated on 29.01.2019. Totally 323 plots of 383 plots were expropriated, i.e., 221 cases of totally 240 cases were completed. Expressed as a percentage, 83.38% of the area covered by the expropriation study was expropriated, including 12 decisions of the FBiH Government on early possession.

PROCUREMENT - SERVICES

Construction works services

Type of procedure: Open procedure without pre-qualification

The bank approved the tender documentation on 23.12.2020 and the tender was announced on the same day. The deadline for offer submission was moved to 22.03.2021. SUB-SECTION TUNNEL KVANJ - BUNA

TECHNICAL DESCRIPTION

The length of the section is 5.1 km and includes a two-tube tunnel with a length of approx. 2.6 km and a bridge with an approximate length of 220 metres.

FINANCING

EIB agreement number 87.195

EU grant: in the Fifth WBIF invitation, a grant was approved in the amount of 20% of the investment, and in the Sixth WBIF invitation, an application for additional 20% was submitted.

PROJECT DOCUMENTATION

Preliminary design was completed. The tender for the procurement of a detailed preliminary design was published, and the opening of offers is scheduled for 28.07.2022. The main design will be prepared by the Contractor since the project is realised according to the FIDIC Yellow Book. On 15.06.2022, a notice was published on the procurement "Preparation of the Detailed Preliminary Design, Corridor Vc, sub-section Tunnel Kvanj - Buna". The deadline for offer submission was scheduled for 28.07.2022, and after an appeal was lodged and the tender documentation was amended, a new deadline for opening of offers was scheduled for 06.09.2022, but in the meantime a new appeal was received and a notice was sent to the bidders on stopping the proceedings, and there is an ongoing preparation of the statement on the subject appeal.

APPROVALS AND PERMITS

The environmental permit was obtained in May 2019.

In December 2019, the Federal Ministry of Spatial Planning issued an urban permit.

The building permit will be obtained after the main design is created by the contractor.

EXPROPRIATION

The municipalities of Čapljina and Stolac and the City of Mostar are responsible for the expropriation procedure. The degree of realisation of expropriation in the territory of the municipality of Čapljina is 100%. The degree of realisation of expropriation in the area of the City of Mostar is 100% of the area (taking into consideration the 2 decisions of the FBiH Government on early entry into possession). In the municipality of Stolac, 100% of the area was expropriated, including 1 decision of the FBiH Government on early entry into possession. Realisation of expropriation on the complete sub-section is 100%.

SUB-SECTION POČITELJ – ZVIROVIĆI LOT 1 and LOT 2

TECHNICAL DESCRIPTION

The length of the section is 11.07 km and it is divided into two LOTs.

LOT 1 consists of a motorway route with a length of over 10 kilometers on which there are significant facilities: Intersection Počitelj with toll booth and access roads, Interregional interchange, three viaducts, a tunnel and an open route.

LOT 2 is the impressive Počitelj Bridge with the length of 980 m. The pillars of the bridge crossing the Neretva river are 92, 97, 92, 91, 88 and 66 m high, which makes it the highest bridge on the Vc Corridor. According to the construction method, it is a continuous pre-stressed reinforced concrete bridge with a box cross-section, which is built using the technology of free cantilever construction.

- Letter was sent to the main office of the contractor for work intensification. The contractor has replaced senior personnel at the site. Consideration of imposition of additional subcontractors pursuant to SC 8.6 of the PCC
- Additional geotechnical investigation works were completed, and they are currently being performed. The designer is involved in the remodeling of the foundation and slopes.
- Established communication procedure as well as the Agreement between all Railway Administrations, Contractors and Clients. The design and construction of barriers was completed.

Current challenges related to the project implementation and undertaken measures LOT 2

Problems:

Long delays on the construction of the span structure. Lack of resources – too little manpower.

The main contractor is still not engaged in the construction of the span structure.

Measures:

Due to long delays in the construction of the span structure, the Engineer issued a Notice on the elimination of defects on 20-Jan-2022. In this Notice, the Contractor was also reminded again that the Contract does not allow subcontracting of span construction.

Several meetings between the management of JP Autoceste FBiH and the Contractor were held.

In his letter dated from 18 March 2022, the contractor obliged to provide two additional pairs of dowels for free cantilever construction in time. On 09 May 2022, the contractor delivered a new work schedule in which he provided for an additional two pairs of dowels for free cantilever construction. However, the contractor brought only one additional pair of dowels, and in his latest work schedule (delivered on 29-Sep-2022), he predicted the use of only one additional pair of dowels for free cantilever construction.

Challenges related to the price escalation LOT 1:

Total price escalation until 30th September is in amount of EUR 1,394,019.79. Estimated price increase escalation until project completion is EUR 3.900.000,00.

6. ENVIRONMENTAL IMPACT

The Law on Environmental Protection (Official Gazette of the Federation of BiH Nr. 15/21) defines the conditions and procedure for issuing environmental permits in the Federation. The FBiH Ministry of Environment and Tourism is responsible for issuing environmental permits for the construction of motorway sections on the Corridor Vc. In chapter 5 of this Report, you can find specific information on all environmental permits that were obtained for the motorways that are under preparation and construction.

The environmental permit prescribes general and special measures to mitigate and avoid negative impacts on the environment during construction and during the use of the motorway, including measures to mitigate impacts on the population, microclimate, water, air, soil, flora, fauna, landscape, protected parts of nature, cultural and historical legacy, existing infrastructure. Special measures also apply to protection against noise and vibrations.

The implementation of the measures prescribed by the environmental permit during the construction is to be performed by the Contractor, and is monitored and supervised by the supervising engineer, while during the exploitation, the implementation is to be carried out by JP Autoceste FBiH with the support of suppliers of specific services, for example for waste water monitoring, noise monitoring, etc.

According to the provisions of the environmental permit, JP Autoceste FBiH is obliged to provide reports to the Federal Ministry of Environment and Tourism no later than 30.06. of the current year for the previous year, which is regularly done.

Apart from the obligations prescribed by the law of FBiH, the JP Autoceste FBiH (together with contractors and supervisory teams) is obliged to implement and monitor the environmental and social standards of European creditors on the Corridor, which entails the preparation of various plans (environmental and social plan, biodiversity management plan, resettlement plan, plan for inclusion of interested parties and other planning documents) for each section financed by funds of EIB and EBRD, and deliver reports on the implementation of above-stated plans to creditors. Also, the Annual Environmental and Social Report is delivered to EBRD for all sections that are financed by them on the Corridor, while information is delivered to EIB through individual semi-annual reports which contain information about the progress in realisation of each of the financing agreements.










Cash Flow Chart 3. Vranduk - Ponirak




Cash Flow Chart 4. Ponirak - Vraca




Cash Flow Chart 5. Tunnel Zenica - D. Gračanica




Cash Flow Chart 6. Tarčin - Entrance to the Tunnel Ivan LOT1


